TERMS AND CONDITIONS

Important notice: Your booking for these vacations involves an agreement between you and those who provide the services. Please read all the information on this page since it sets out the conditions covering the travel and other services offered.

BOOKING

Upon signing your registration form a deposit of 25% to **Spiritours** with an international money order, by personal check (Canada only) or by credit card using the "Authorization for debit on credit card" form. The balance is due no less than 60 days from departure. The tour operator reserves the right to cancel your booking if payments are not received within 5 days after their due date.

CANCELLATION CHARGES

60 days and prior: penalty of 25%

From 60 to 30 days: penalty of 50%

Less than 30 days: no refund

Changes to a Booking: 50\$ charge. Changes within 30 days of departure will be considered as a cancellation.

INSURANCE

We suggest that you take a trip cancellation or interruption insurance in case of sickness, hospitalization, death of the covered person or a member of his family, a disaster (fire, flood, etc.), loss of employment or another major reason.

SPECIAL REQUESTS
